**SUPPLEMENTARY APPROPRIATION (2026) ACT, 2026**

[Gazette Dated: June, 2026] [Commencement: Section 2]

An Act to revise the total appropriation from the Consolidated Fund of Anguilla for the services of the Government of Anguilla for the 2026 financial year.

ENACTED by the Legislature of Anguilla

**Supplementary Appropriation**

1. On the authority of a warrant issued by the Minister of Finance, there may be expended from the Consolidated Fund, for the financial year ending on 31st December 2026, such monies not exceeding in the aggregate Six hundred and fifty-seven million, six hundred and thirty-one thousand, three hundred and nine dollars (\$657,631,309) in respect of the services of the Government of Anguilla set out in the Schedule to this Bill, being the revised total appropriation for those services for the 2026 financial year.
