A BILL FOR

**PORT NIMARA MARINA (ANGUILLA) (BERTH SLIPS) ACT, 2025**

[Gazette Dated: , 2025] [Commencement: Assent under section 57 of the Constitution]

The purpose of this Act is to establish a legislative framework to provide for the registration of berth slips in Port Nimara Marina and to provide for related matters.

ENACTED by the Legislature of Anguilla

**Interpretation**

1. (1) In this Act—

“berth slip” means a designated space of property as described in Schedule 2 at Port Nimara Marina where boats may be docked or moored once the owner of the boat is registered as its owner or leasehold owner;

“common property” means those parts of Port Nimara Marina designated on the Port Nimara Marina Plan for shared access or use by berth slip proprietors, tenants or licensees including docks, walkways, utilities and facilities which shall remain vested in the owners of Port Nimara Marina;

“land” means land covered with water, other things permanently affixed to land and includes the area set out in Schedule 1;

“Port Nimara Marina” means those areas of land (including coastal land), foreshore, bed of the sea, and water-space, described in Schedule 1;

“Registrar” means the Registrar of Lands;

“property” includes—

(a) any structure—

- (i) above-water appurtenant to coastal land, or
- (ii) above submerged land; and
- (b) berth slips.

(2) This Act shall be interpreted in accordance with the Registered Land Act and where an issue arises, the Registrar shall be guided by the provisions of the Registered Land Act and accompanying registry and land policies with the necessary adjustments being made to ensure workability for the registration of berth slips.

(3) To avoid doubt, a berth slip registered under this Act shall constitute immovable property within the meaning of the Registered Land Act and may be the subject of ownership, lease agreements, mortgages or charges in the same manner as a parcel of land.

(4) The Port Nimara Marina Plan shall be treated as a survey plan with the necessary adjustments being made.

(5) Nothing in this Act prevents the owner of a berth slip from engaging in renting their berth slip or from allowing their berth slip to be used temporarily by transient users.

### **Filing of Port Nimara Marina Plan**

2. (1) The owner of Port Nimara Marina is prohibited from selling, leasing or renting any berth slip unless that slip forms a part of the Port Nimara Marina Plan that has been registered.

(2) In accordance with the terms and conditions directed by the Registrar, the owner of Port Nimara Marina shall file at the Registry the Port Nimara Marina Plan setting out the collective unit of berth slips that are available for sale.

(3) The Port Nimara Marina Plan shall include—

- (a) a brief description of the marina property with sufficient detail to identify it and its location;
- (b) the area of the plan that is demarcated for berth slips;
- (c) a reference number for each berth slip which is clearly demarcated;
- (d) the dimensions and size of each berth slip and the size boat it can accommodate;
- (e) an indication of where the common property is located; and
- (f) any other matter that the Registrar considers necessary to effect registration of the Port Nimara Marina Plan and each berth slip.

(4) Where the Port Nimara Marina Plan has been registered any subsequent amendments may be approved or rejected by the Registrar within 30 days from the date of filing.

(5) Where the Registrar has rejected any proposed amendments, the Registrar shall inform the owner of Port Nimara Marina in writing about their concerns with an indication of what needs to happen for the proposed amendments to be approved.

(6) Berth slip owners must comply with the terms and conditions of the Port Nimara Marina Berth Slips Master Declaration.

### **Port Nimara Marina Berth Slips Register**

3. Where the Registrar is satisfied that the Port Nimara Marina Plan is in order, the Registrar shall open the Port Nimara Marina Berth Slips Register setting out—

- (a) a number which is allocated to each berth slip;
- (b) a brief description of each berth slip;
- (c) the name and address of the first proprietor of each berth slip;
- (d) a space to indicate the name and address of any subsequent owner;
- (e) any encumbrances, easements or restrictions on usage or sale as determined by the Registrar; and
- (f) any particulars that the Registrar considers should be noted in relation to the berth slips.

### **Berth Slips Master Declaration**

4. (1) The owners of Port Nimara Marina must file a Port Nimara Marina Berth Slips Master Declaration before it divests itself of any berth slip.

(2) The Port Nimara Marina Berth Slips Master Declaration must set out the following—

- (a) in a general manner, an indication of how Port Nimara Marina will be operated and how the marina will be operated in relation to berth slips;
- (b) matters pertaining to the insurance of the property with particular emphasis placed on the insurance of berth slips and the insurance of common property;
- (c) the rights and responsibilities of a berth slip owner in relation to a berth slip and common property;
- (d) the rights and responsibilities of the owner of Port Nimara Marina in relation to a berth slip and common property;
- (e) how disputes will be handled with particular emphasis placed on alternative dispute resolution procedures;
- (f) how safety procedures will be handled particularly in relation to natural disasters (with special emphasis placed on hurricanes) and fire and rescue operations; and
- (g) any other matter that the Registrar considers to be relevant.

(3) Where the Registrar holds the view that the Port Nimara Marina Berth Slips Master Declaration should not be registered, the Registrar must inform the owner of Port Nimara Marina in writing about their concerns with an indication of what needs to happen to effect registration.

(4) No amendment shall be made to the Port Nimara Marina Berth Slips Master Declaration unless that amendment was filed at the registry.

(5) Where the owner of Port Nimara Marina would like to amend the Port Nimara Marina Berth Slips Master Declaration, the owner must satisfy the Registrar that all persons that may be affected received adequate notification of any proposed changes.

### **Registration of a berth slip proprietor**

5. Where the owner of Port Nimara Marina or any subsequent berth slip owner has entered into a sale or lease agreement, the Registrar may register the buyer of the berth slip as the proprietor with absolute or provisional title or as the proprietor of a lease if the Registrar is satisfied that—

- (a) where necessary, an aliens land holding licence was granted;
- (b) the stamp duties were paid;
- (c) the transferor and the transferee of the berth slip has obtained a certificate of good standing; and
- (d) the fees associated with the registration of berths have been paid.

### **Role of Superintendent of Ports**

6. (1) The Superintendent of Ports under the Ports, Harbours and Piers Act shall have the right to access Port Nimara Marina at any time after providing reasonable notice.

(2) Notwithstanding subsection (1), where the Superintendent of Ports is of the view that notice cannot be provided, the Superintendent may enter Port Nimara Marina.

### **Regulations**

7. (1) The Executive Council may make regulations to give effect to any of the provisions of this Act.

(2) Without prejudice to the generality of subsection (1), the Executive Council may make regulations—

- (a) prescribing matters required or permitted to be prescribed by this Act;
- (b) providing for matters as may be—
  - (i) contemplated by or necessary for giving full effect to this Act and for its administration, or
  - (ii) incidental to or consequential upon any provision of this Act; and
- (c) providing for penalties; and
- (d) providing for further technical specifications relating to the Port Nimara Marina Plan.

**Consequential amendment**

8. The Ports, Harbours and Piers Act is amended in section 3(a) by adding the following phrase at the end of the paragraph “and the private sector”.

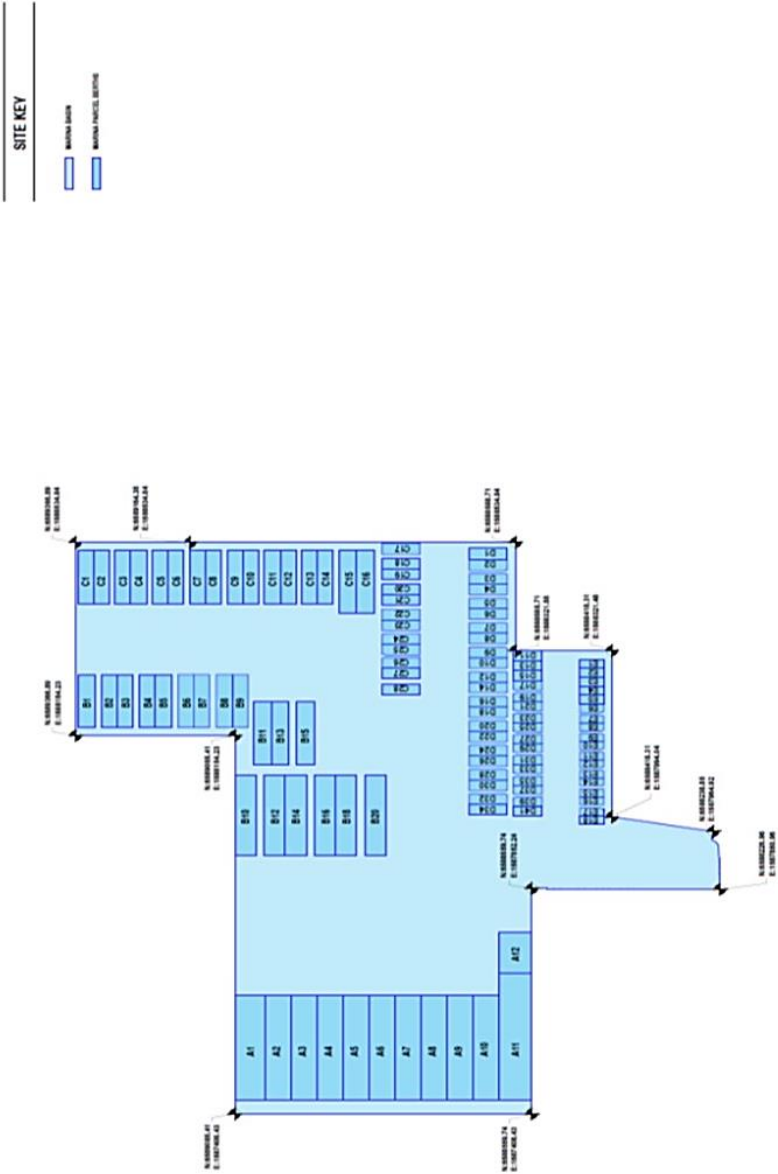
